

92Y Residence Rules and Regulations:

COVID-19 Amendment (Effective 1/15/22)

In order to provide a safe living environment for our residents during these unprecedented times, please find the following COVID-19 amendments to the 92Y Residences Rules & Regulations.

COVID-19 Vaccination Requirement:

- Residents are required to be fully vaccinated and those eligible must have received their booster dose prior to moving in to 92Y Residence. Those not yet eligible, will have to receive their booster dose within 2 weeks of becoming eligible for a booster (5 months after the 2nd dose of the Pfizer or Moderna vaccine or 2 months after the Johnson & Johnson vaccine).
- Proof of vaccination (CDC Vaccination Card or Locally Issued Vaccination Card) must be submitted prior to moving in and then again after a booster vaccine is administered.
- All CDC and WHO approved vaccinations will be accepted.

General Precautions to Be Adhered to:

- Residents must always wear a mask covering both nose and mouth, when in communal areas and throughout 92Y. The following are not acceptable: gaiters, bandanas and masks with vents.
- Please wash your hands frequently for 20 seconds or use hand sanitizer (which is located throughout the building) when unable to wash your hands.
- If you have a fever or do not feel well, please notify the Residence Office and consult with your physician on next steps.

Guest Policy: Partially Suspended

- Day guest privileges are still suspended; Unexpected guest will not be allowed into the building.
- All guests must be fully vaccinated and have received their booster vaccine if eligible.
- Residents are required to submit proof of their overnight guest's vaccination and a copy of their ID when submitting an <u>Overnight Guest Pass Request</u> form prior to their guest's arrival. If you are in a double room, you will have to submit your roommate's approval to have a guest.
- Overnight guest stays are \$15 per night or \$25 per night if a rollaway bed (not guaranteed) is requested by 3pm of your guest's arrival date.
- Guests can stay a maximum of 3 nights. Guests will have to leave 92Y by 12pm on the date on the back of your guest pass. You will then be allowed to have another guest 7 nights after your guest leaves.
- All other Guest Policies as detailed in the 92Y Residence Guide will be in effect.

In Your Room:

- · Housekeeping services are suspended.
- Brooms and mops are provided in the janitor's closet of your floor for your use.
- Trash bags for your room can be picked up from the Residence Office and you can discard your trash in the trash bins on your floor.

Kitchen/Dining Room:

- Please wipe down all surfaces (kitchen counter, range knobs/handle, refrigerator handle, freezer handle, tables, etc.) before and after use with provided disinfecting spray and paper towels.
- Wash your dishes and utensils after using the kitchen and take back to your room. Anything found in the kitchen will be discarded.

Bathroom:

- Avoid placing personal items (including toothbrushes) directly on the surfaces.
- You are encouraged to use a shower caddy/tote to bring your personal items to the bathroom with you and back to your room.

Laundry Room:

• Please wipe down all surfaces on the washing machine and dryer before and after use with provided disinfecting spray and paper towels.

Resource Room:

- Please wipe down all surfaces before and after use with provided disinfecting spray and paper towels.
- Open window to permit proper air circulation.

Communal Area Cleaning:

- Kitchens, bathrooms, dining rooms will be cleaned and sanitized at least twice per day and as needed throughout the day.
- Stairwell rails and exit push bars will be cleaned and sanitized once a day.
- Elevator button panels will be cleaned and sanitized twice a day.

Required Testing for SARS CoV-2 (Covid-19):

92Y Residence requires all incoming residents to submit a SARS CoV-2 (COVID-19) test taken within 3 days of arrival.

If you feel ill with COVID-19 symptoms, please get a PCR AND rapid antigen test for COVID-19. If your test result comes back positive for COVID-19, you are required to inform the Residence Office immediately. You will be required to make arrangements to return home or move to an offsite location which will provide a more suitable environment for recovery. If you need any assistance in making these arrangements, contact the Residence Office or you can call NYC 311 to make arrangements with the New York City COVID-19 Isolation Hotel Program. You will have to isolate offsite for 5 days from the date symptoms first appeared AND until you have no fever AND other symptoms have resolved. As long as you meet these criteria, with the 92Y Residence Office approval, you will be allowed to move back to your room. As per our rules, you must continue to wear your mask when you are in any communal space. If you are still symptomatic after 5 days of isolation, you will have to continue isolating offsite for 10 days. After which, with the approval of the 92Y Residence Office, you will be allowed to move back to your room. If you are in a shared room, you will have to complete a full 10-day isolation offsite. After your 10-day isolation, with the approval of the 92Y Residence Office, you will be allowed to move back to your room. Upon returning to your room, we recommend you continue to wear your mask while in your room with your roommate.

While you make your arrangements, you will be required to move to a designated room on an isolation floor immediately.

If you cannot find an offsite location to move temporarily, please contact the Residence Office.

If you choose not to move to the designated room within 92Y Residence, you will be required to move out immediately.

In signing this amendment, you agree to comply with all the above rules & regulations. These rules are subject to change based on recommendations and guidance from the CDC, the New York State Department of Health, and/or the New York City Department of Health. You understand that failure to follow these rules & regulations will result in disciplinary action, including termination of your residency at 92Y Residence.
